Terms & Conditions of Supply

Basis of Sale

- > These terms and conditions alone shall govern the sale of goods by us and shall not be varied without prior written consent.

Orders

- > We specifically reserve the right to reject orders placed with us or with our agents without ascribing a reason.

New customers

- > New customers who require a trade account must provide two trade references and place an order in excess of £250.
- > The first order will be accepted on a pro-forma basis only. Following a successful application credit may be provided.

Price

- > The price and specifications of the goods shall be those quoted in the prices list current at the date your order is received. Prices and specifications are subject to alteration without notification and at our sole discretion.

VAT

- > VAT at standard rate is included in the Suggested Retail Price as shown in our price lists.

Direct Despatch

- > Without exception all customers taking advantage of our direct despatch service are set up on a proforma basis.
- > On Direct Despatch orders, any end customer returns/exchanges, must be taken to stock by the retailer. Any damaged or faulty goods sent direct will be exchanged/credited in full.

Carriage

- > For standard trade orders delivery will be made by the cheapest courier service available to us and charged at cost.
- > For direct despatch customers delivery will usually be sent Recorded Delivery. The following costs are a guideline:

0-100g	£	1.68
101-200g	£	1.95
251-500g	£	2.38
501-750g	£	2.88
751-1000g	£	3.38
1001-1250g	£	5.42
Every 250g thereafter	£	0.85

- > Higher value orders will be sent via either Royal Mail or Parcel Force and charged at cost.

Overdue Accounts

- > We shall be entitled to charge you interest at 3% on all overdue accounts from the date due to the date paid together with the amount of any and all costs incurred by us resulting from late payment including but not limited to fees of debt collections and solicitors and court charges.

Delivery

- > Any dates of delivery provided by us are estimates only and do not form part of our contract with you and time and delivery shall not be the essence of the contract.
- > Items in stock are normally despatched same day on a 48 hour service.

Damage to goods

- > We will not be liable to damage, pilferage or shortage of goods on delivery unless claims are notified in writing to the carrier within 3 days of delivery and to ourselves within 10 days of delivery. The packaging, including outer wrappings must be retained for examination. Our liability whether for breach of these terms or otherwise shall not in any event exceed the price of goods which the claim relates.

Retention of title

- > The property in the goods will not pass to you until payment of the price for the goods has been made in full. Until such time you will hold the goods as our bailee and fiduciary agent and will store the goods separately from other goods so that they can be identified as our property and keep the same protected and insured.
- > Until the property in the goods has passed to you, you shall be entitled to resell or use the goods in the ordinary course of your business but shall account to us for such element of the proceeds of sale or otherwise of the goods, including insurance proceeds as is equivalent to the price and shall keep all such proceeds separate.
- > In applying for credit account facilities we agree to Internet Fusion Ltd trading as Trade Fusion terms and conditions.
